

## Terms and Conditions of the “E-commerce season 2026” ("Offer")

### Responsible entity

These terms and conditions are issued by PayU S.A., with registered office at 60-166 Poznań, ul. Grunwaldzka 186, 60-166 Poznań, Poland, office in the Czech Republic Na Strži 61a, 140 00 Praha 4, registered in the Register of Entrepreneurs maintained by the District Court in Poznań - Nowe Miasto i Wilda in Poznań, 8th Commercial Department of the National Court Register under KRS No. 274399, with a share capital of PLN 7,789,000.00, fully paid up, tax identification number (NIP): 779-23-08-495, hereinafter referred to as "**PayU**".

### Scope of application

The Terms and Conditions determine when and how PayU may reduce the fees payable under a contract with a merchant (hereinafter referred to as the "Contract"). The current contents of the Agreement can be found on the website: <https://czech.payu.com/en/legal-documents/>

**"Merchant"** means a party to the Contract with PayU. The Merchant may be an adult natural person conducting business, a legal person or an unincorporated entity granted legal personality by law.

### Terms and Conditions of the Offer (hereinafter referred to as "Terms and Conditions")

1. The Offer is valid for Traders who meet the criteria set out below and consists of a reduction of certain fees payable to PayU as follows:

a) Activation fee is 200 CZK

b) for the first three months of cooperation with PayU:

i) the fee for Transactions in CZK made by online transfer is 1 % of the value

of the Transaction + 1 CZK,

ii) the fee for Transactions in CZK made via credit card is 1 % of the value of the Transaction + 1 CZK,

iii) the fee for Transactions in CZK made via Klarna is 1,99 % of the value of the Transaction + 5,80 CZK,

c) after the first three months of cooperation with PayU:

- i) the fee for Transactions in CZK made by online transfer is 1,45 % of the value of the Transaction + 1 CZK,
  - ii) the fee for Transactions in CZK made via credit card is 1,45 % of the value of the Transaction + 1 CZK,
  - iii) the fee for Transactions in CZK made via Klarna is 1,99 % of the value of the Transaction + 5,80 CZK,
- d) Reduction of fees for other PayU services in accordance with the Agreement.

2. The offer is valid **from 15.01.2026 to 31.03.2026**.

#### **Rules for using the offer**

The offer applies only to Merchants who enter a Contract with PayU and meet all the criteria set out below:

- a) register by applying to use PayU Services via the web website available at:

and pay the Activation fee during the offer period (the amount must be credited to the bank account PayU **by 31.03.2026**);
- b) have accepted at least one Transaction within the Service made via any payment channel - except for the "test payment" - of those described on this website:

- c) successfully complete PayU verification in accordance with the Agreement.
